Patterns in Responses

A simple way of gauging the strength of feeling for individual questions is to add Strongly Agree/Agree and compare it to Strongly Disagree/Disagree

For example for question 1, this becomes, 96:4. In this way we can identify opinion which is skewed either towards
Agreement or Disagreement, or evenly spread, for example Question 7, 70:30.

Overall, Comments were Positive:

- -Parents are very positive about the use of Seesaw as a communication tool. They want less paper and more electronic forms and procedures (not via FAX or hand-delivered).
- -The Office performance is commended by parents.
- -Parents feel listened to and would welcome even more feedback regarding their children's progress (Seesaw should provide this).
- -We currently issue reports three times per year and issue individual test scores; however due to COVID we have not been able to have Parent Teacher Conferences.
- -"As a parent, I have been incredibly impressed at how the school has utilized Seesaw as a communication tool. Seesaw allows me to regularly and easily communicate directly with my children's teachers. Their communication back to me is quick and allows for us to best support our children together from home and from school."

Teaching and Learning - Comments

Overall, Comments were Positive and Constructive:

- -Parents emphasized the importance of maintaining the school's emphasis on developing English for all students while also fostering the Japanese language.
- –It is clear that distance learning due to the prevention of COVID, left a burden on families to provide extensive support, especially for youngest children.
- -However, parents also report knowing more about the curriculum and academic content as a result of distance learning and Seesaw.
- 'I think the teachers are taking care of each and every child very carefully."
- 'I want to praise the school for their response to the coronavirus through distance learning. Using Seesaw and Zoom allowed for my children to stay on-track with their learning while having teachers available to provide support and feedback. It also allowed me to track my children's learning better."

School Climate - Comments

Overall, Comments were Extremely Positive:

- -Parents are tremendously pleased with the climate of the school and the safety of their children, especially in light of the coronavirus.
- –Parents remarked that they wish that they could be more involved and be able to connect more face-to-face via conferences and events, but understand that this is not possible during the current situation when parents are not allowed on campus.
- "We thank you from the bottom of our hearts for all the efforts you have made to deal with the coronavirus crisis to create an environment in which parents and students can feel secure." 'I feel comfortable when I visit MIS. I think the children feel the same way and go to school with such a comfortable feeling."
- "The school is nicely decorated and immaculately clean. Especially the library's book selection is remarkable in every aspect."

Conclusion



- The overall tone of the survey responses was very positive. 22 out of 30 questions had an overall satisfaction rating over 80%. 16 out of 30 questions had over a 90% satisfaction rating.
- In comparison to the last two year's data, there is an increase in satisfaction ratings in many areas and much higher 'Strongly Agree' ratings over the past two years.
 This suggests a greater overall confidence in the school.
- The written comments were constructive and will help guide our school improvement.
